Totally Alive and Casey Terry may, in their sole discretion, cancel or change the schedule of all or any part of any program or extension if it considers such action to be in the general interest of participants or their safety, and I waive all claims against Totally Alive and Casey Terry arising from such actions or decisions. Totally Alive and Casey Terry reserve the right to substitute support person/s and to alter the itinerary when necessary. All prices quoted are valid at the time of publication and every effort is made to honor the original published pricing; extraordinary circumstances may warrant revisions and Totally Alive and Casey Terry reserve the right to revise final landcost pricing when necessary. If it is necessary for Totally Alive or Casey Terry to revise final pricing before departure, you will have the option of receiving a full refund if you choose to cancel 10 days prior to departure.

I undertake the following obligations.
